Federal Government Continues to Fall Behind In Responding to FOIA Requests, CJOG Finds

Analysis Tracks Ongoing Slide in Information Released to the Public

June 30, 2006

The federal government continues to fall further behind in getting information to people seeking public records under the Freedom of Information Act.

The backlog of requests, a critical indicator of information delays, rose from 20 percent in 2004 to 31 percent in 2005, despite a decline in the volume of requests, according to a survey of 22 agencies and departments by the Coalition of Journalists for Open Government. Had these departments and agencies maintained their 2004 level of processing requests, there would have been no significant backlog.

Agencies also said "no" more often—and spent more to do so.

The deteriorating performance is reflected in individual agency reports filed for the fiscal year that ended Sept. 30, 2005, just a few months before President Bush's Executive Order requiring federal departments and agencies to conduct an internal examination and find ways to improve service to FOIA requesters.

CJOG reviewed the reports of 13 Cabinet-level departments and nine agencies handling the highest volumes of third-party FOIA requests, which come from individuals, organizations and corporations seeking non-personal information.

Steadily growing complaints about the difficulties in getting government data led Congress to take up the OPEN Government Act of 2005, designed to reform the 40-year-old Freedom of Information Act, and subsequently the president's Executive Order.

The Coalition analysis includes but separates data from the Department of Health and Human Services, the Department of Veterans Affairs and the Social Security Administration because more than 90 percent of the requests they receive are also filed under the Privacy Act and come from individuals seeking personal records. HHS, the VA and SSA handle the bulk of information requests to the federal government, grant almost all requests and do so within a few days.

The CJOG analysis showed:

- **The backlog got worse.** The 22 departments and agencies had 148,603 requests unprocessed at the end of 2005, or 31 percent of the total number handled. In 2004, the backlog was 20 percent. The Securities and Exchange Commission and the Department of Housing and Urban Development were the furthest behind, with backlogs of 131 percent and 127 percent, respectively. Only seven agencies improved their performance.

CJOG findings, continued:

- **Agencies got stingier with their records.** The agencies and departments surveyed said 63 percent of all requests in 2005 resulted in full or partial grants (the official government term for the release of public information). The year before, they granted 67 percent of requests.
- **Requesters had to wait longer.** Agencies and departments do not record how long requestors have to wait to get information, only how long it takes to tell people whether a request will or will not be granted. These data are misleading, however, because they reflect median times, not average, and many departments and agencies do not report their overall performance. Instead, they show only the median times recorded by the component FOIA offices. That makes it impossible to assess department-wide performance. What the data do show is that more agencies had greater median response times in 2005 than those who reported less time to get back to requestors. There's no reason to believe the subsequent release of information followed a different pattern.
- **The worst delays got worse.** The Securities and Exchange Commission said median waiting time on its 1,099 complex requests was 410 working days, more than double the median a year earlier. (There are 261 federal working days a year). One Agriculture Department component reported its median response time for complex requests was 1,277 working days. A Justice Department unit put its complex median response time at 863 days.
- **Cost went up as service fell.** The cost for each request handled by the 22 departments and agencies rose 6 percent to \$490.81, even as the backlog grew and requesters waited longer to find out if they would get the information sought.
- **Rather than catch up, the government cut FOIA costs.** The government reduced both the number of employees working on FOIA requests and overall costs, even as the backlog and slow processing times continued. Efficiency—as measured by the employee days it takes to handle a request—remained unchanged.
- **The failure to respond was not always the result of workload.** Some agencies noted the length of time that requests unprocessed at yearend had been pending. The National Archives said its median for backlogged requests was 1,631 working days, more than six years. One Treasury Department component reported a median backlog time of 648 days, about 2.5 years.
- **The appeals process improved nominally.** The percentage of appeals granted in full or in part went up slightly, from 17 percent to 18 percent. The backlog of appeals decreased along with an overall decrease in the number of appeals.
- **The government continued to prevail in litigation.** The government won outright in 56 percent of the cases resolved in court in 2005. Requesters won outright only 3 percent of the time.

CJOG findings, continued:

- **The use of broad discretionary exemptions to withhold information increased.** Departments continued to increase the use of Exemption 2, internal agency procedures, and Exemption 5, internal and inter-agency memos, to withhold information. These exemptions were recommended in administration instructions designed to tighten restrictions on release of information that were sent to departments and agencies in 2001 and 2002 by then-Attorney General John Ashcroft and then-White House Chief of Staff Andrew Card. Although there were fewer requests and the overall use of exemptions to deny requests declined by 7 percent from 2004 to 2005, the use of Exemption 2 increased 37 percent and the use of Exemption 5 by 5 percent.

The Coalition also compared the 2005 FOIA data with reports from 2000, the last year before the current administration took office. That analysis showed that while the number of FOIA requests has dropped 21 percent, there has been an even greater decrease (23 percent) in the number governmental employees working on FOIA. At the same time, there was a 31 percent increase in the spending on FOIA processing costs and a 66 percent increase in the per request cost.

Median Days: Not all agencies aggregate response-time data. Instead, they report by component. In those instances, the "Median Days" shown reflect the range—the lowest and highest of the times.

Justice reported granting only 177 of the 536 expedited review requests, so 17 of the requests processed in 2005 must have been carried over from 2004's stack of requests to be expedited.

Social Security does not report Median Days for requests processed in its 1,400 field offices. It says that most are dealt with on the first day. Unlike other agencies, it breaks its own FOIA processing into a fourth, Fast Track, category.

Justice also said the Executive Office of U.S. Attorneys, EOUSA, does not keep separate cost records on FOIA cases, so litigation expenses have been estimated. EOUSA worked on 257 cases during the year. The report assumes an average of 100 hours for each case and allots \$50.18 per hour for the staff attorney's time. EOUSA also had \$284,001 in other FOIA litigation costs for a \$1,573,687 total.
